Magnesium is used as a Viersalz[®] complex, which offers a particularly broad solubility spectrum with four different magnesium salts. Another bonus: The Mineralstoff Formula is now vegan.

Minerals and trace elements are essential for human life. They are building blocks for bones, teeth, hair and nails and form the basis for the fluid balance, nerve excitation and hormonal processes. In particular with increased need, as it can occur particularly in the growth, in pregnancy and quiet time or with achievement sportsmen, an attention should be put on the mineral material household. In these special phases the targeted supply of minerals can help to keep the mineral balance in balance. Biogena Mineralstoff Formula contains a spectrum of essential minerals and trace elements and is therefore an all-round balanced basic complex for use in all situations.
